## 2010 Federal Tax Schedule (Circular E)

The 2010 Federal Tax Schedule (Circular E) is now available for downloading.

#### 2010 Federal Tax Schedule (Circular E)

You will find the Withholding Allowance Schedule on page 37, the Annual Tax Schedule located on page 39, Table 7. Continue using the annual table for ASP software and adjust accordingly for Vision based on frequency. Social Security and Medicare Taxes are defined on page 18. Setup your earnings limit as 106,800, the deduct limit as 6621.60, and the rate remains at .062. Note: If you have multiple Social Security and Medicare rates, adjust accordingly.

#### Note:

Vision software customers do nothing; Simply watch for our annual publish of Vision Financials update that automatically updates the federal tax rates.

## **IRS Announces 2010 Standard Mileage Rates**

WASHINGTON — The Internal Revenue Service today issued the 2010 optional standard mileage rates used to calculate the deductible costs of operating an automobile for business, charitable, medical or moving purposes.

Beginning on Jan. 1, 2010, the standard mileage rates for the use of a car (also vans, pickups or panel trucks) will be:

- 50 cents per mile for business miles driven
- 16.5 cents per mile driven for medical or moving purposes
- 14 cents per mile driven in service of charitable organizations
